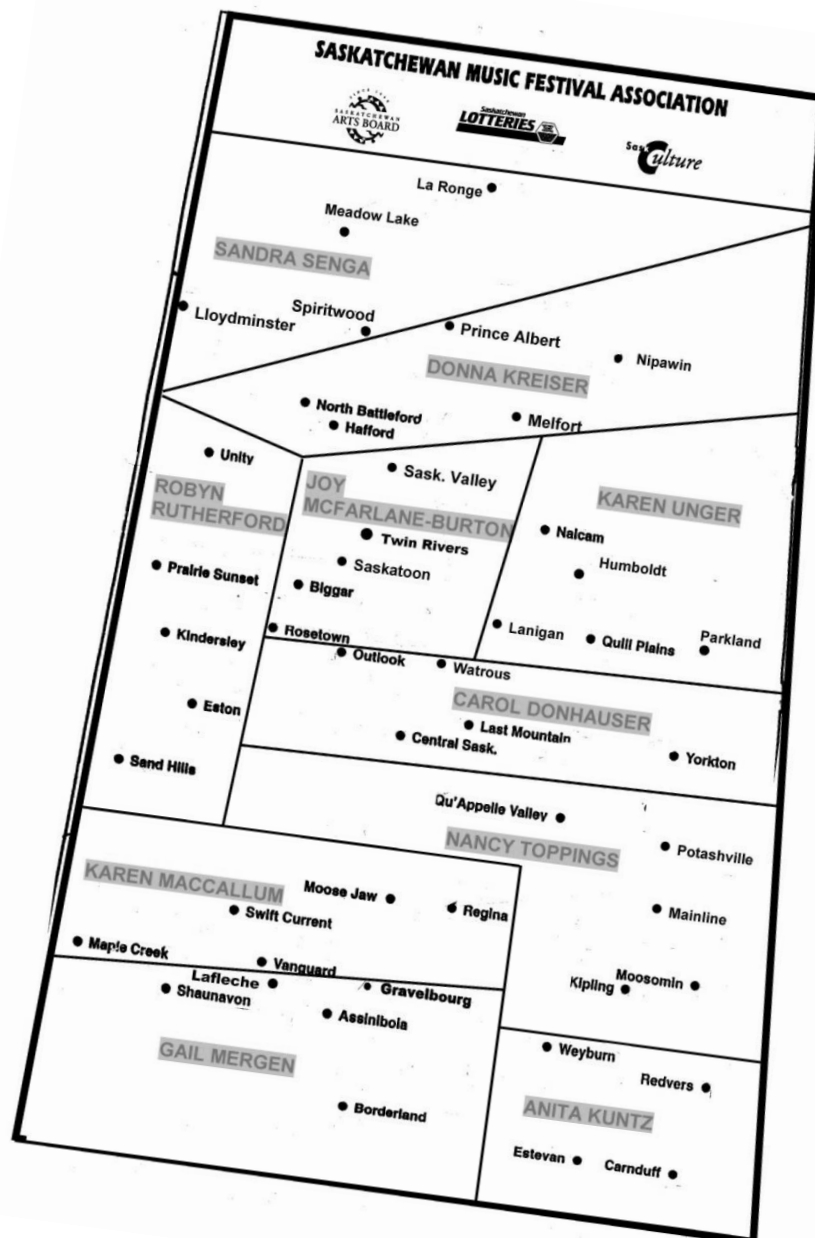

Cultural Impact Statement

In 1905, Saskatchewan became a province. Since 1908, the Saskatchewan Music Festival Association (SMFA) has grown with our province, always in step, always in tune. The SMFA reaches out to people of all ages and all backgrounds across the province of Saskatchewan. The Saskatchewan structures and programs have been modelled throughout Canada.

Our mandate, which is "to promote excellence in music and speech arts by providing performance and educational opportunities through competitive festivals," requires us to work closely with the many (numerous) people who come together to keep the festival movement in Saskatchewan alive and well. These people include music and speech students, teachers, parents, volunteers, donors and audiences. There are 48 annual festivals across the province, therefore the impact that is created in all these 48 festivals and surrounding areas is significant.

These communities have embraced the festival concept because it provides:

- an element of educational growth as well as entertainment that brings their community together
- the opportunity for communities to acknowledge and support the success and endeavours of their young people
- encouragement for students to set goals and showcase their abilities while receiving constructive adjudication from professional musicians
- local volunteers an opportunity to be involved with young people in their community in a positive way
- participating students with the performance opportunity to develop confidence and self-discipline while demonstrating positive role models for their peers

Since its early days, the Association has provided competitive and non-competitive classes for not only solo and individual competitors, but for community and schools in choruses, bands and orchestras. SMFA's continued expansion encouraged the formation of other provincial music organizations. Saskatchewan was not only the first to form a Provincial Music Festival Association, but also the first to use a common syllabus for all its member festivals. The use of the common syllabus assures that a high standard is maintained.

SMFA partners with the other music organizations across Saskatchewan to ensure that the programs we develop are relevant to the needs of our young people. Accessibility to programs and recognizing changing demographic circumstances within the province is a high priority. The broad-based volunteer component of SMFA allows the organization to operate at the grass roots level thereby closely monitoring these changes and adapting to them. Every attempt is made to ensure that the experience attained by participants is beneficial and works in concert with the SMFA vision which is to develop individuals with positive life and performance skills.

SMFA believes that the need for a culturally aware society is of increasing importance given the pressures exerted upon us by the rapid, electronic environment in which we live. Our organization is committed to cultivating that awareness by providing information, education, opportunity and a clear vision of the role we play in this task.

Executive Director's Report

"Many hands make light work". According to a report the Canada Survey of Giving, Volunteering and Participating (CSGVP) released in April 2012, the youngest age group (ages 15-24) represents the highest percentage of volunteers (at 58%) and people between 35 and 44 are a close second at 54%. Similar to what is seen in financial giving, those who occupy the 65 + category donate the largest number of hours. Saskatchewan and Prince Edward Island show the highest volunteer rates.

2012 Saskatchewan Music Conference

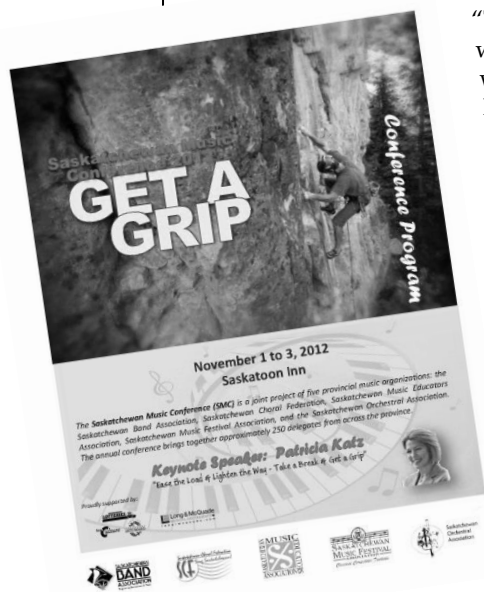

2012 AGM Minutes

**Saskatchewan Music Festival Association
Annual General Meeting
November 3, 2012**

1. The meeting was called to order at 12:15 by President Joy McFarlane-Burton.
2. Canada was sung, led by Anita Kuntz. A moment of silence was observed in memory of all festival volunteers who had passed away since last year.
3. Joy McFarlane-Burton appointed Gail Mergen as recording secretary.

Motion: Cheryl Leptich/Linda Alberts to accept the Agenda as circulated. CARRIED

4. Theresa Brost conducted the roll call with 23 district festivals present.
5. Theresa Brost presented two nominations for upcoming vacancies on the Board of Directors: Sandra Senga and Donna Kreiser. Theresa made the 1st call for further nominations from the floor.
6. Minutes from the 2011 AGM were read.

Motion: Nancy Wilkins/Kelly Stein to accept the minutes as printed. CARRIED

7. Business Arising from the Minutes
 - a) Finance Report – presented by Karen MacCallum.

Motion: Sandra Senga/Elaine Poirier to change the SMFA year-end to August 31 (from July 31) to align with other provinces. CARRIED

Motion: Karen Unger/Darren Schwartz to accept the Finance Report as printed. CARRIED

Motion: Gail Brown/ Anita Kuntz to appoint R.G. Blakeley Accounting as Auditor for the fiscal year 2011/ 2012. CARRIED

Karen MacCallum provided more information on the Statement of Operations: \$8,721 surplus was realized (page 57 of Annual Report) \$10,000 was put into reserve fund. Lottery fundraising project: 1790 tickets were sold for \$17,960. \$7450 was reimbursed to district festivals.

Karen MacCallum detailed 17 benefits that festivals receive from their affiliation fees! The Board seeks to manage assets responsibly, and to keep improving what is offered in our festivals. "Become a Festival Friend" campaign was outlined.

Questions from the floor:

- Lloydminster Festival asked if venues in Alberta are covered by SMFA liability insurance. Venues would have to see the actual insurance document before making that decision.
 - What kind of account is the reserve fund? The account is a bank account, with excess from the Century Club funds.
- b) Highlights from the Annual Report were presented. The President's Report was given by Joy McFarlane-Burton, and the Executive Director's Report was given by Carol Donhauser.

- c) The Board of Directors was introduced, as well as office staff Carol Donhauser and Sandra Kerr.
 - d) Theresa Brost made the 2nd call for nominations from the floor.
8. New Business
- a) 2013 Concerto Competition will be held Feb. 22, 23 in MacKenzie Art Gallery, Regina, with sponsorship by new donor Bill Shurniak. Shauna Rolston has been added as a judge.
 - b) Wallis Opera Competition will be held in 2014 on the same February weekend.
 - c) SMFA Provincial Finals will be held in Saskatoon for the next three years - 2013, 2014, and 2015. There is a savings of \$8,000 by holding competitions at the U of S.
 - d) 2013-15 Syllabus will be available online next week. Theresa Brost was the very capable editor; thank you Theresa!
 - e) 2013 Directory will also be available online soon. There are some regulation changes from last year's publication.
 - f) Website Update: Carol Donhauser reported that the projected launch date is November 15, 2012. Each district festival will have its own html page, to allow for online registrations and PayPal payments. SMFA will work with festivals to set up their web presence. Meadow Lake Festival gave details of their online procedures last year; 80% of families did register online, most with PayPal payments. They also accepted payment by cheque. Meadow Lake suggested that a confirmation that entries were received was needed, in addition to the confirmation from PayPal that payment was received.
 - g) Greetings were received from the following associations and friends: Laureen Kells, vice-president of SRMTA thanked volunteers for opportunities for students to shine. Joy McFarlane-Burton thanked all for attending on behalf of Canadian Music Festivals Adjudicator Association. Honorary Life Member Lillian Mitchell reported that she is enjoying the perks of long life, and values the happy associations with old and new friends within SMFA.
 - h) Elections - Theresa Brost made the 3rd and final call for nominations.
Motion: Karen MacCallum/Linda Alberts moved nominations cease. CARRIED
Sandra Senga (Meadow Lake) and Donna Kreiser (Prince Albert) were elected by acclamation. Each gave details of their biography, and Joy McFarlane-Burton welcomed them to the SMFA Board of Directors.
 - i) **Motion: Janelle Willabee/Robin Swales to ratify decisions of the Board from the past fiscal year. CARRIED**
 - j) The next Saskatchewan Music Conference, and SMFA AGM, will be held October 31, November 1 & 2, 2013 at the Delta Hotel, Regina.
 - k) Sandra Kerr presented the Best Program Award to Battlefords Music Festival. Criteria included creativity, easy navigation, and all logos/advertising used as required.

- l) Darren Schwartz acknowledged and introduced the festival representatives from his liaison region: Battlefords, Sask Valley, Twin Rivers, and Saskatoon. This liaison region had the most festivals in attendance at the AGM.
- 9. Other Business
 - a) Anita Kuntz, on behalf of SMFA scholarship committee, will be sending letters to district festivals requesting sponsorship for provincial scholarships. Thanks were extended to Anita and Gail Mergen for their work on the scholarship committee.
 - b) Thank you's were also given to Carol Donhauser and Sandra Kerr for their excellent office management, to the planning committee of SMC, and to retiring Board members Darren Schwartz and Theresa Brost.
 - c) New SMFA President Karen MacCallum received the SMFA official gavel from out-going President Joy McFarlane-Burton. A gift was presented to Joy in appreciation of her term as SMFA president.

Saskatchewan Music Alliance



2013 saw continued collaboration among the five provincial music organizations – Saskatchewan Band Association (SBA), Saskatchewan Choral Federation (SCF), Saskatchewan Music Educators Association (SMEA), Saskatchewan Music Festival Association (SMFA) and Saskatchewan Orchestral Association (SOA). While a formal structure has not officially been adopted, the five groups operate as the Saskatchewan Music Alliance (SMA) with a view to moving toward a formalized governance and operational structure. The SCF continues to act as the administrative organization for the SMA.

The Transition Team has acted as a de facto Board of Directors for the SMA this year. These individuals have worked very hard to lead the SMA towards increased collaboration, as well as approve the work plan, evaluation reports and financial statements of the organization. Thanks and appreciation go to Jennifer Tenford, Wendy Goodhand, Aaron Thingelstad, Joy McFarlane-Burton, and Curtis Scheschuk.

A Management Committee has been established with staff from each of the five organizations and is responsible for the overall coordination and day to day activities of the SMA. The Management Committee develops and implements the annual workplan, benchmarks success, oversees the financial commitments and reports to the Transition Team on progress. The Management

Committee also establishes committees, hires staff, and contracts consultants as required.

A Conference Committee led by the Saskatchewan Band Association has been established to oversee the organization of the annual music conference. The Saskatchewan Music Conference has been a collaborative effort of the five music organizations since 2009 and brings together delegates from across the province to network and develop skills.

Advocacy efforts included focus groups and a literature review which will eventually lead to a focussed campaign for change with agreed upon goals by all the groups. The SMFA and SOA are leading the Advocacy initiative and a committee will be struck in the near future to review the data collected to date.

Another successful initiative has been the Summer Music Camp which is now operating in Regina, Saskatoon and Prince Albert. The development, promotion and administration of the program were led by the SMFA and SOA and it is hoped that the program will continue in the future.

The five music organizations continue to review progress made to date in order to determine whether to formally incorporate the SMA.



Adjudicator Liaison Report

In 2013, over 170 assignments were contracted to musicians from 8 different provinces and 3 states to judge our district festivals, the Concerto Competition, and Provincial Finals competitions.


New last year was the Adjudicator Application/Information form. The SMFA Board thought it would be advantageous to have our adjudicators fill out this form every three years, not only to add to the information we already have on file, but for professional musicians to formally indicate their interest to adjudicate. While this doesn't guarantee an assignment it provides a roster from which I can select when considering the requirements of each festival.

The Adjudicator Liaison job was a little overwhelming at the beginning of my first year. After contacting the people who were requested by the festival committee, the challenge was deciding on the next step. With 175 spots to fill it was a little daunting to know where to start. Many factors influence the process so it is not such a simple task to hire each festival's adjudicators, but the job was completed. I breathed a little easier once all adjudicators were confirmed, however our winter storms played havoc on more than one occasion, as you will read in some of the festival reports. Nevertheless I hope the festival experience was a positive one for students, parents, teachers, and the community.

Hiring for the 2014 season began in July, and though many professionals were away on holiday, they appreciated being contacted early to be booked for the upcoming year. About half the spots were filled by the end of July, with the remaining to be completed by the end of the calendar year.

SMFA Concerto Competition

In 1979 three Saskatchewan organizations celebrated 70th anniversaries: the Saskatchewan Music Festival Association (SMFA), the Regina Symphony Orchestra (RSO) and the Regina Cartage and Storage Co. Ltd. To celebrate these events, directors of the three groups announced a joint sponsorship of an Anniversary Concerto Competition, open to young Saskatchewan musicians.

The 30th SMFA Concerto Competition took place Saturday, February 23 in the Shumiatcher Theatre at the MacKenzie Art Gallery, Regina. This event was sponsored by Mr. Bill Shurniak, and attracted six performers from across Saskatchewan. Alto saxophonist Gerard Weber of Saskatoon gave the afternoon's winning performance of *Concerto for Alto Saxophone and Orchestra, Op. 26*, by Paul Creston. This 20th - Century work features ever-shifting rhythms and an energetic vitality, with a hauntingly sweet 2nd movement. Bonnie Nicholson was the superb accompanist on piano.

Gerard is currently finishing a Bachelor of Music in Applied Study and Performance at the University of Saskatchewan. He studies saxophone with Dr. Glen Gillis. Gerard performs regularly with the U of S Wind Orchestra, Jazz Ensemble, Saxophone Quartet, and Saxophone Choir. He plans to continue graduate studies in the USA next year. Gerard's prize from the Shurniak

Concerto Competition includes \$2000, and performances with the Regina Symphony Orchestra and the Saskatoon Symphony Orchestra.

Other performers included Eric Bews (Saskatoon), William Boan (Saskatoon), Alyssa Ramsay (Regina), Austin Castle (Swift Current), and Jessica Ramsay (Regina). Jessica Ramsay, violinist, was awarded 2nd place, and her sister, Alyssa Ramsay, cellist, was selected as 3rd place.

The audience was very appreciative of the high calibre of musicianship shown. Three distinguished musicians adjudicated the competition: Audrey Andrist, pianist, formerly of Estevan, now from Washington, D.C.; Maxim Antoshin, Executive Director of RSO; and Shauna Rolston, cellist, from Toronto. In announcing the winners, Audrey Andrist mentioned that she herself had won this competition during the "Jurassic Age" (1980!), and that it had been a great benefit to her career.

The next Shurniak Concerto Competition will be held February 2015 in Saskatoon. The SMFA opera and concerto competitions are held in alternate years.

Congratulations to the performers, families, Committee, and community volunteers for another highly successful Battlefords area music Festival. Together we provided an exciting range of musical performances and educational opportunities. Since many parents, family, friends, and the general public enjoy coming out to support the hard work of Festival participants, our continued use of weekend days, allowing for easier access within everyone's busy schedules, was much appreciated. Furthering our goals to maintain easy access to view performances, we experimented this year with utilizing one large space venue for most performances in all disciplines.

We were pleased that Speech Arts entries, both individual and choral speaking, continue to increase warranting the inclusion again of an adjudicator specifically for speech arts in addition to having an adjudicator assigned for vocal music entries. It was exciting to see schools celebrate the work of their group entries within their own walls utilized as a Festival venue allowing the students of a given school to support and learn from each other.

The weekly newspaper column "Festival Fanfare" continued this year and was again well received. Our post-Festival meeting served not only to allow us to give each other a well-deserved pat on the back, but also to allow us to quickly set goals for next year or two and fine tune areas that require more attention. We worked with local school Divisions to help facilitate a choral speech workshop for local teachers during a Spring PD in order to further build on the growing local successes in this area.

For 2014 plans we will continue to experiment with balancing the discipline schedule, continue to make use of weekend days, will consider the pros and cons of one overall central venue, will again include speech arts separate from voice, may experiment with having two separate voice music adjudicators so as to feature musical theatre independently, and culminate the Festival with our usual Gala and Awards evening!

Carnduff & District Music and Arts Festival

We had 99 competitors with a total of 266 entries this year. Piano entries stayed about the same – we did lose some seniors due to graduation, however, we did have new competitors to keep our numbers stable. Guitar numbers were stable. There were no choral

speech entries; however, Carnduff Education Complex did send two competitors per class from Kindergarten to Grade 9. We did have some 4-H entries this year and hope to get more next year. We hope to spark some interest with the Cadet program. Band entries were up. Vocal – we had 2 choirs this year. Solo vocal entries were down from last year so we are hoping to come up with ideas to promote this class. This was the first year we asked for three adjudicators. For the most part, this worked out very well and we will likely request the same for next year. We continued with our poster contest, however, it was just done at the one school. We were able to present a total of 58 awards and a total of \$2115.00 in scholarships.

Central Sask Music Festival

(Davidson)

The Central Saskatchewan Music Festival has not experienced a decline in entries for the past number of years, so it was with great disappointment that our 2013 entries were down by 20 percent. Most of this loss was due to our most senior piano students choosing other activities. However, our remaining participants had a wonderful festival experience due to our two very supportive and entertaining adjudicators, Anna Marie Bekolay and Mark Turner. The 2013 festival's issues were not however over with our reduced entries, as the evening of our Grand Finale a late winter storm prevented half of our award winners from arriving from the surrounding areas to take part in our program, with a similar reduction in the audience attendance. Nevertheless, an intimate evening of performance and socializing was warmly received. We have been fortunate to recruit a new executive member who is very interested in promoting our Speech Arts classes throughout the district, as her role in the education system puts her in touch with a number of schools within our festival area. Her interest and enthusiasm gives us cause to be





very optimistic for the recovery of our entry numbers. We are pleased to report that our financial and volunteer supporters are extremely faithful and that our executive remains intact.

Estevan & District Music Festival

By combining the two disciplines, we are able to have more flexibility with scheduling and benefit with the continuity of one adjudicator for the students. Eleanor Epp, Brandon, completed our festival with the piano discipline. She was in Estevan for 6 days with both senior and junior piano.

The young and older students all received good adjudications suited to their age.

Even though our entries were down this year, we increased the value of our scholarships handed out. Over \$11,000 was handed out to well-deserving students. We also present our 7 and under participants with medals and a special certificate. We collected over \$2000 from our Friends of the Festival and we are very fortunate that our Festival has a secure financial foundation every year. We are able to keep our entry fees low and they should not be increasing for the next year.

This year we collected funds to support The Colin Grunert Memorial Intermediate Brass Award at the Provincial Festival. Colin was a band director in Estevan for more than 20 years and passed away a few years ago. He was instrumental in supporting our festival and he was a tremendous community member. We are honoured to be a part of this award.

As a new President, I would like to thank each dedicated committee member for all the work they do. I am fortunate to be a part of this fabulous organization that continues to nurture music in our community.

Maple Creek & District Music Festival

The program reveals 124 individual entries as well as entries from six school bands, four school classes, one drama club, and two Musical Theatre groups, in 103 classes. Thirty-seven individual participants performed, several in multiple disciplines. Two adjudicators presided over eleven sessions, of piano, strings, voice, speech arts, woodwind, brass, and band ensemble classes.

We were to have three adjudicators this year but the weather gods conspired against this plan. Dr. Christine Vanderkooy arrived as planned to preside over our Monday opening day piano sessions. In mid-afternoon we were informed by Dr. Pauline Minevich that the roads from Regina to our area were impassable and she had to return home. Panic reigned briefly. We assured Dr. Vanderkooy that it would be impossible for her to return to Regina that evening. She could see the wisdom in this and agreed to take on the task of adjudicating the String session in the evening. She also decided that she could manage to do the Bands and Band solo classes the next day, if we could snuggle up sessions so that she could get home to Regina by Tuesday evening. She did a very good job and did get home safely. We were very fortunate that our Voice and Speech Arts adjudicator, Jeri Ryba, also travelled from Moose Jaw on the Tuesday to be ready for the Wednesday and Thursday sessions as the road deteriorated again between Regina and Swift Current after she arrived. We're sure that there will be many such stories around the festivals after the winter of 2013. Some of our competitors and their parents also had hair-raising trips to the festival.

We were very pleased to have entries from the Gull Lake School Band Program for the first time, joining the Bands from Maple Creek. It has been a long time since Maple Creek bands used to enter the former Gull Lake Festival. We hope this is a beginning of a new tradition. \$2075.00 for thirty-five scholarships was presented at the Festival Finale to individuals



and ensembles. Each year we conduct a program cover competition at the elementary school level. This year the prize of \$50.00 was awarded to Jillian Broderick of Maple Creek.

Chelsea Cox received scholarships and trophies for her performances in Speech Arts and Voice. She was presented with the Maple Creek & District Outstanding Performer Award and was recommended to Provincials in three categories: Heather Laxdal Memorial Senior Grade B Female Voice; Nancy & Alastair Todd Memorial Senior Vocal Grade B Concert Group; and L.I. Bryson Memorial Senior Speech Arts.

David Hudec was also recommended to Provincials to compete in the Regan Grant Memorial Intermediate Musical Theatre Ballad class.

The Finale evening concluded with a reception for the participants and the audience. A local lady and festival parent, Connie Mulatz, created a vast array of decorated cupcakes which we had with fruit and cheese. It was all delicious.

This year we were pleased to have a good supply of volunteers throughout the week. We are always grateful for the continuing community support for scholarships, program advertising, and contributions of time.

Several who performed also received awards and scholarships. Participation awards were handed out for 5 and 10 consecutive years of involvement in festival. Regina Music Festival

The RMFA enjoyed a festival in the spring of 2013 which can be counted among the best in recent years for the high collegiality and smooth operation demonstrated through the work of its board members, volunteers, participants, and adjudicators. While the number of participants was slightly down from 2012, the 1385 entries surpassed 2011. It was especially encouraging to see a high number of junior piano and string entries and the return of a contingent of trombonists who had been scarce in the last year or two. A further development with promise for the future was a return to school music through the Catholic School Board and some significant entries in

percussion. No organ competition was held because of the decline in organ teaching with the closure of Holy Rosary Cathedral for several months of renovation work. Thirty-five individuals and two choirs were recommended for the Provincial competition and the festival contributed five soloists and two choirs for the provincial level of National competition. The festival awarded well over one hundred scholarships of which sixteen were new. Revisions to ten scholarships generally increased their amounts at the request of the donors. Three were cancelled and eight were not awarded of which four were the organ scholarships. The Celebrating Excellence final concert featured ten of the best soloists in the festival, two trios, and one choir and was recorded and broadcast by SaskTel Max.

If one excludes the scholarships awarded through annual donations, the festival costs approximately \$60,000 to run and we recorded a slight surplus for the year. The artsVest initiative was successfully approached for matching funds and we received \$1750 in each of the three years 2012-3 to 2014-5 from three partners matched in year 1 by \$1750 from artsVest for a total commitment of \$7000. Taken together donations for the operation of the festival and for scholarships amounted to over \$40,000 for the year 2012-3. Considerable generosity was once again shown by the main festival location sponsors Luther College on the university campus but welcome assistance came also from The Royal Saskatchewan Museum, Knox Metropolitan Church, Lakeview United Church, and the Conservatory of Performing Arts at all of which sections of the festival were held. Yamaha Pianos provided several instruments as they have done for many years.

A wine and cheese gathering was held at Diana Woolrich's home to which music teachers were invited. The idea was to explain the festival opportunities to some who had not been entering students or who were new to the city.





One of the young students gave an excellent talk on her experiences with the festival and the whole event was considered valuable and very enjoyable.

The year concluded with the resignation of Penny Penniston and Colleen Kembel who served as President, Programme Manager, Recording Secretary and Office Manager for many years. Both felt that they should recognise that the festival was in good hands and that they had an opportunity to conclude their efforts over the years. The board was sorry to see them go but understood their position and hopes to use them as consultants or indeed as active members. Dianne Swanson took up the post of Interim President and was elected President at the Annual Meeting in September. A new Programme Manager has been appointed and the RMFA looks forward to a lively year introducing on-line registration and a new computer management system to create greater efficiency.

Rosetown Music Festival

The Rosetown Music Festival continues to provide local music students the opportunity to perform in the community and benefit from the constructive comments of the adjudicators. In 2013, the 247 entries were held in 16 sessions from March 12 – 22. We thank our wonderful adjudicators Garry Gable, Lenora Bells, and Heather Blakley for encouraging and guiding our young musicians on their music path. In true Saskatchewan style, Heather Blakley had to spend an extra day in Rosetown due to bad roads!

Shaunavon & District Music Festival

This year the Shaunavon & District Music Festival Association welcomed participants from Admiral, Bracken, Claydon, Climax, Eastend, Frontier, Gull Lake, Shaunavon, and Val Marie, showcasing the musical talent from each of these communities.

198 participants performed eighty-four selections. Fifteen of these pupils were new participants! The performers included vocal and speech art students, three school choirs, and many piano students. Five vocal/speech arts/school group sessions and five piano sessions were held during the four-day festival.

Centre Street United Church was the venue for all sessions this year as the community's grand piano was relocated from the Public School to the church in partnership with the Shaunavon Arts Council. The Arts Council paid for the moving costs and the Music Festival funded staging to accommodate the piano, and for a piano cover. The use of the grand piano for festival was enjoyed by participants and audience! Our final concert was held on the evening of April 18 at the Salem Lutheran Church. One noteworthy performance included "Shaunavon for Everyone" by the Shaunavon Public School choir, in celebration of Shaunavon's Centennial in 2013.

Advertisements of the Festival were conducted in a radio interview, local newspapers, and school newsletters. Programs were available in Eastend, Frontier, and Shaunavon prior to the festival, as well as at the venues.

Gary Gullickson was our voice adjudicator and Lana Ramsay adjudicated piano. Both adjudicators offered sound and encouraging advice to our participants, and were very personable.





Under the direction of our adjudicators, our Scholarship committee awarded 38 scholarships to children aged 9 & up, totaling \$3875, including \$300.00 to school groups. Major donors were: Cenovus Energy, Bob & Phyllis Phair, the former Shaunavon Band Association, HoneyBee Manufacturing, Town of Shaunavon, Town of Eastend, Eastend Arts Council, Knights of Columbus, and the Houston family sponsoring the Beth Houston Memorial Scholarships. Program Enhancement

Speech Arts Workshops

This year, speech arts workshops were held in the southeast corner of the province, in schools at Kipling, Kennedy/Langbank, Whitewood, Broadview and Grenfell. Heather Macnab, speech arts specialist from Maple Creek, conducted 4 days of workshops for students from Grades 2 to 9. A total of 311 students were exposed to the speech arts during those 4 days, as well as 24 staff members and 6 festival volunteers and community members.

Heather's presentation is highly interactive and adapted to each age group. (Even a reluctant class of Grade 8 students was drawn in with a lively game of Zip Zap Zop!) The students participate in exercises to develop confidence and communication skills.

They are exposed to different poetry styles and learn how to express themselves through spoken words, gestures, and facial expression. She introduces the students to the variety of speech arts opportunities available to them in the festival syllabus, and in these particular workshops, focused primarily on poetry, storytelling, and public speaking. First Nations poetry and stories were included in the repertoire.

SMFA Speech Arts Workshops are supported by the SMFA Program Enhancement Fund.

SMA Summer Music Camp

The SMA Summer Music Camp is an initiative by the Saskatchewan Band Association, Saskatchewan Choral Federation, Saskatchewan Music Educators Association, Saskatchewan Music Festivals and the Saskatchewan Orchestral Association in collaboration with the Dream Brokers Program and support from SaskCulture. Potash Corp, SGI, Conexus Credit Union, and Access Communications provided additional funding and in-kind contributions were provided by Long & McQuade, First Student Canada, the University of Saskatchewan, and the University of Regina.

The goal of the camp is to provide the opportunity for students grade 4 to grade 8 to experience music and its positive influence, who may not have the opportunity to do so otherwise. The camp was held, under the direction of Amy Nelson, Camp Coordinator, in Saskatoon July 8 – 11, 2013 (52 students), Prince Albert July 15 – 18, 2013 (26 students) and in Regina July 22 – 25, 2013 (32 students) and gave students a four-day intensive introduction to a number of musical instruments including: Guitar, Violin, Piano, Percussion, Band, Choir, First Nations' Hand Drumming and Story Telling.



The 2013 Annual Provincial Finals Competitions and the Saskatchewan level of National Music Festival Competitions were held May 31, June 1, & 2, 2013 in Saskatoon at the University of Saskatchewan.

Judges for the weekend were: Senior Piano: Tannis Gibson (Tucson, AZ); Intermediate Piano: Stephen Runge (Sackville, NB); Senior Voice: Carolyn Hart (Wheaton, IL); Strings: Andrée Azar (Longueuil, QC); Percussion/Brass/Woodwinds: Fraser Linklater (Winnipeg, MB); Speech Arts/Musical Theatre/Intermediate Voice: Monica Huisman (Winnipeg, MB), and Choral Judge: Andrée Deganais (Brandon, MB).

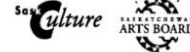

Federation of Canadian Music Festival (FCMF) Business Meeting Report

The 64th Annual Federation of Canadian Music Festival Association AGM and National Music Festival Competition was hosted by Waterloo, Ontario, on August 8 - 10 2013, at Wilfrid Laurier University.

Saskatchewan voting delegates were: Karen MacCallum, Joy McFarlane-Burton, and Carol Donhauser. Anita Kuntz also attended as conference observer and designate.

The past year was a good year financially with the operating budget carrying over the surplus of \$17,000 from last year. About \$11,000 was moved to an Emergency Reserve Fund as per a 2009 motion.

The following is a list of relevant motions passed at the FCMF AGM.

Motion: That we accept the invitation of Kelowna to host the 2014 National Music Festival at the University of BC Okanagan. Gloria Nickell/Norma Jean Atkinson. Carried.

Motion: That FCMF appoint Heather Robinson as the auditor for the fiscal year ending 31 October, 2013. Mary Ross/Joan Woodrow. Carried.

Motion: That the Federation of Canadian Music Festivals offer a contract to Heather Bedford-Clooney for the position of Executive Director for the 2013-2014 Festival year, effective November 1, 2013 for \$26,5000 [including expenses]. Mary Ross/Joan Woodrow. Carried.

Motion: That the revisions to the By-laws, having been circulated as stipulated and with required notice, be accepted as presented. Gloria Nickell/Karen MacCallum. Carried.

Motion: That the revised Musical Theatre class wording be accepted as presented. Joy McFarlane-Burton/Martha Gregory. Carried.

Motion: That the listing of life members includes deceased members indicated with [D] so that their contribution to the Federation of Canadian Music Festivals continues to be acknowledged. Barbara Long/Diane Campbell. Carried with some no votes.

Motion: That FCMF engage legal counsel for the purpose of developing a clear set of guidelines for use by all music festivals in Canada with regard to the use of: Photocopied music for performance in music festivals; Electronic music for performance in music festivals; and that FCMF cover the cost of the legal work referenced above to a maximum cost of \$1000. Wendy Durieux/Carol Donhauser. 26 in favour, 6 against. Carried.

Elections were held and Marilyn Wiwcharuk (BC) was acclaimed as President and Rheel Fournier was acclaimed as Vice President. Gloria Nickell of Saskatchewan was re-elected for a two-year term and Susan Belleperche was elected for a one-year term.

Financial Report

The Saskatchewan Music Festival Association (SMFA) is committed to financially responsible decision-making, in order to maintain a strong Festival movement and offer effective programming throughout the province.



Nancy Toppings,
Finance Chair

The Finance Committee consists of First Vice-President Nancy Toppings (Chair), President Karen MacCallum, Second Vice-President Karen Unger, Past-President Joy McFarlane-Burton and Executive Director Carol Donhauser. This committee is responsible for overseeing all financial matters, budget preparation, presenting solutions and responding to financial issues at the Association board table.

Our financial goal is a balanced budget, and we are pleased to show a surplus in the fiscal year ending July 31, 2013. Our funders recommend that an organization maintain a minimum reserve fund of 10% of their operating budget. (An operating reserve is an unrestricted fund set aside to stabilize a non-profit organization's financial position by providing for unexpected cash flow shortages, expense or loss.) For the second consecutive year, we were able to transfer \$10,000 to the SMFA reserve fund, which currently totals \$37,602.

In order to maintain operations at the current level, SMFA is dependent on funding from the Saskatchewan Lotteries Trust Fund for Sport, Culture and Recreation. We are deeply grateful for this support. Our Annual Global Funding application was approved for the three-year cycle ending July 31, 2016. An increase for program enhancement in Years 2 & 3 will enable us to expand the speech arts workshops into more district festival communities.

We acknowledge the support of the Saskatchewan Arts Board, SaskCulture Inc., PotashCorp, SaskEnergy, SaskTel, Enbridge Inc., the University of Saskatchewan Music Department, Regina Symphony Orchestra, Saskatoon Symphony Orchestra and Mr.

William Shurniak. SMFA was fortunate to be the recipient of a Business for the Arts Grant (Canadian Heritage; Government of Saskatchewan Ministry of Parks, Culture and Sport; and support of SaskCulture) which matched funds received from new sponsors of our Provincial Finals (Solvera, Executive Royal Hotel, Source Office Furnishings, Beyond Wealth Management, and Adam Niesner Realty). We sincerely thank the many scholarship donors, patrons and contributors to our Festival Friends campaign. Your generosity ensures that music festivals continue to thrive in communities across this province.

Our investment fund is currently managed by Leander Dueck and John Hrycak of Beyond Wealth Management of Regina. Leander comments: "Over the past year, the investment portfolio has achieved an exceptionally good return of 14.25%. This is significant given the benchmark return of the TSX was 4.78% for the same period."

I wish to extend my appreciation to the Board for their cooperation throughout this fiscal year. We will continue to move forward with responsible financial decisions on behalf of the Association and its membership. Special thanks to Carol and Sandra, our dedicated Provincial Office staff, for their guidance and support.

INDEPENDENT AUDITOR'S REPORT

To the Members of
Saskatchewan Music Festival Association

I have audited the accompanying financial statements of Saskatchewan Music Festival Association, which comprise the statement of financial position as at July 31, 2013, and the statements of operation, change in net assets and cash flow statement for the years then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

In common with many non-profit organizations, Saskatchewan Music Festival Association derives part of its revenue from the general public, the completeness and classification of which are not susceptible to satisfactory audit verification. Accordingly my verification of these transactions was limited to accounting for the amounts recorded in the records of the organization and I was not able to determine whether any adjustments might be necessary to the revenues, statement of operations, assets and net assets.


Qualified Opinion

In my opinion, except for the effects, if any, of the matter described in the Basis for Qualified Opinion paragraph, the financial statements present fairly, in all material respects, the financial position of Saskatchewan Music Festival Association as at July 31, 2013 and its financial performance and its cash flows for the years then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Other Matter

The financial statements of Saskatchewan Music Festival Association for the year ended July 31, 2012, were audited by another auditor.

NOTES TO THE FINANCIAL STATEMENTS
JULY 31, 2013**

1. Status and nature of activities

Saskatchewan Music Festival Association is incorporated under the Non-Profit Corporations Act of Saskatchewan. Under present legislation, no income taxes are payable on the reported income of such operations. The purpose of Saskatchewan Music Festival Association is to provide a classical, competitive music festival system of the highest standard at the local, provincial and national levels.

2. Adoption of Canadian accounting standards for not-for-profit organizations

Effective August 1, 2012, the Association adopted Canadian accounting standards for not-for-profit organizations. These are the Association's first financial statements prepared in accordance with these accounting standards and the transitional provisions of Section 1501, First time adoption by not-for-profit organizations, have been applied. Section 1501 requires retrospective application of the accounting standards with certain elective exemptions and limited retrospective exceptions. The accounting policies set out in the significant accounting policy have been applied in preparing the financial statements for the year ended July 31, 2013 and the comparative information presented in these financial statements for July 31, 2012. The Association issued financial statements for the year ended July 31, 2012 using generally accepted accounting principles prescribed by the pre-changeover standards of the CICA Handbook - Accounting. The adoption of accounting standards for not-for-profit organizations had no impact on the previously reported assets, liabilities and surplus of the Association and accordingly, no adjustments have been recorded in the comparative statements of financial position and the statements of operations and cumulative surplus. In addition, as no changes were required, an opening statement of financial position at August 1, 2011, the Association's date of transition, has not been presented.

3. Summary of significant accounting policies

These financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations and include the following significant accounting policies:

Inventory

Inventory is valued at the lower of cost and net realizable value.

Tangible capital assets

Tangible capital assets are recorded at cost. Amortization is provided on a diminishing balance method over the assets' estimated useful lives as follows:

Equipment	10 %
Furniture and fixtures	10 %
Leaseholds	5 years

Full amortization is recorded in the year of purchase.

Revenue recognition

Grants from Saskatchewan Lotteries Trust Fund for Sport, Culture and Recreation are received out of the net proceeds of lottery ticket sales in Saskatchewan. These grants have been recorded as revenue by Saskatchewan Music Festival Association as approved by Saskatchewan Lotteries Trust Fund for Sport, Culture and Recreations. Accordingly, amounts received that relate to the next fiscal period are shown as deferred revenue.

3. Summary of significant accounting policies cont'd

Financial instruments

The Saskatchewan Music Festival Association initially measures its financial assets and financial liabilities at fair value. It subsequently measures all its financial assets and financial liabilities at amortized cost.

Financial assets subsequently measured at amortized cost include cash, investments and accounts receivable. Financial liabilities subsequently measured at amortized cost include accounts payable and accrued liabilities.

Management estimates

The preparation of the financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amount of revenues and expenditures during the reporting period. By their nature, these estimates are subject to measurement uncertainty and the effect on the financial statements of changes in such estimates in future periods could be significant.

8. Funds held in trust

Per the Association's by-laws in the event that a District Festival Association ceases operation or becomes inactive for a period of two consecutive years or more, all funds of that District Festival Association are to be transferred to the Provincial Association and be held in trust for a period of five years. If the District Festival Association is not reinstated within the five year period then the funds become the funds of the Provincial Association.

9. 2013 SMA Summer Music Camp Program

Saskatchewan Music Festival Association, Saskatchewan Band Association, Saskatchewan Music Educators Association, Saskatchewan Orchestral Association and the Saskatchewan Choral Federation entered into an agreement to administer a Summer camp music program. Saskatchewan Music Festival Association was the administrator of this program. See schedule 7 for a breakdown of revenue and expenses.

10. Lease commitment

A lease agreement exists with Niesner Properties Inc. for the premises known as 4623 Albert Street in Regina, Saskatchewan. A 5 year term commenced December 1, 2012 requiring a base monthly rent of \$900 plus GST. This agreement expires November 2017. The Association is also responsible for their portion of property taxes and operating costs.

A lease agreements exists with IOS Financial Services for a photocopier. A four year term commenced March 2011 requiring monthly payments of \$129 plus taxes.

A lease agreements exists with Pitney Bowes for a postage machine. A five year term commenced April 2011 requiring monthly payments of \$78 plus taxes.

11. Economic dependence

The Saskatchewan Music Festival Association receives significant revenue in grants from Saskatchewan Lotteries Trust Fund for Sport, Culture and Recreation. As a result, the Association is dependent upon the continuance of these grants to maintain operations at their current level.

12. Financial instruments

Saskatchewan Music Festival Association is exposed to various risks through its financial instruments. The following analysis provides a measure of the Saskatchewan Music Festival Association's exposure and concentrations at July 31, 2013:

Credit risk

Credit risk arises from the potential that a party may default on their financial obligations, or if there is a concentration of financial obligations which have similar economic characteristics that could be similarly affected by changes in economic conditions, such that the organization could incur a financial loss. The Association is exposed to credit risk with respect to cash, investments and accounts receivable. The Association manages its credit risk by placing cash and investments with major financial institutions. Credit risk for accounts receivable is managed by the credit quality and diverse debtor base and creating an allowance for bad debts where applicable. There has been no change from credit risk exposure from 2012.

Liquidity risk

Liquidity risk is the risk that the Association may not be able to meet a demand for cash or fund its obligations as they come due or not being able to liquidate assets in a timely manner at a reasonable price. The Association is exposed to liquidity risk with respect to its investments and accounts payable but manages its liquidity risk by holding assets that can be readily converted into cash. There has been no change from liquidity risk exposure from 2012.

Interest rate risk

Interest rate risk is a type of market risk that refers to the risk that the fair value of financial instruments or future cash flows associated with the instruments will fluctuate due to changes in market interest rates. The Association is exposed to interest rate risk with respect to its cash and investments and its effect on interest income. Fluctuations in interest rates do not have a significant effect on cash and investments due to the fact that interest income is not a major percentage of total revenue. There has been no change from interest risk exposure from 2012.

13. Comparative figures

The comparative figures were reported on by another accountant and certain figures have been reclassified to conform with the current year's presentation.
