

DISTRICT FESTIVAL ENTRY FORM

Important:

- 1. The current SMFA Syllabus, Regulations, Scholarship Information, dates and contacts for each District Festival, and other important information concerning the Festival(s) you wish to enter, can be found on our website at: www.smfa.ca.
- 2. Use a separate entry form for each class entered.
- 3. Send completed entry form(s) with payment to the Entry Secretary/Administrator of the District Festival you enter, on or before the entry close date. Check the District Festival page on the SMFA website for applicable fees.
- 4. Make cheques payable, or send e-transfers where applicable, to the District Festival you are entering.

Noteworthy Regulations:

- 1. All competitors must supply an **original score or authorized copy** for the adjudicator. Please number the first bar of each line (music scores), and each fifth line (Spoken Word selections).
- 2. Refer to the SMFA Website for each District Festival's Scholarship and Awards criteria.
- 3. To be recommended as a **District Winner to the Provincial Finals Competition** <u>each individual named on the entry form</u> must have entered and competed in at least two **solo** classes in the same discipline. Instrumentalists must compete in two **solo** classes on the same instrument <u>with the exception of percussion</u>, where <u>performers play more than one percussion instrument</u>. This rule does not apply to the pianist in the lieder classes. **Note: Musical Theatre and Voice are separate disciplines.**
- 4. At Provincial Finals, District Winners <u>may compete in only ONE of Senior, Intermediate or Junior scholarship categories</u> <u>in the same discipline.</u> District Winners may compete in <u>Grade A OR Grade B Voice</u>.
- 5. Competitors are required to represent the District Festival where they received their first recommendation.
- 6. Memory work is mandatory at the provincial level of competition (with the exception of the pianist in Lieder class 10267, and in Canada West Excellence Chamber Classes 10980 and 10981). In all other Canada West Excellence Classes (excluding Choral), memory work is mandatory at the district festival level, in order to a to the provincial level of competition.

WAIVER AND RELEASE *** PLEASE READ CAREFULLY

Viral and infectious diseases including but not limited to COVID-19, SARS, MERS and Influenza (the "Diseases") are highly contagious and are believed to spread mainly from person-to-person contact. Public Health Guidelines have indicated that risk of transmission increases through singing or the use of musical instruments and equipment.

Notwithstanding attempts to put in place preventative measures to reduce the spread of Diseases, Saskatchewan Music Festival Association (SMFA) cannot guarantee that you and/or your child(ren) will not become exposed to any Diseases as a result of participating in music festivals.

By signing this agreement, I acknowledge:

- 1. The highly contagious nature of Diseases and the Public Health Agency of Canada (PHAC) and the Provincial and Territorial authorities recommend maintaining distance between participants to reduce the spread.
- 2. SMFA cannot guarantee that I and/or my child(ren) will not become infected with a Disease, and by voluntarily attending music festivals, I acknowledge that myself and/or my child(ren) are increasing our risk of exposure to a Disease.
- 3. I, and/or my child(ren) voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself or my child(ren), and hereby release, waive, discharge SMFA for any and all liabilities, claims, demands, actions and causes of action whatsoever, directly related to any loss, damage, injury or death that may be sustained by myself or my child(ren) related to any Diseases while participating in music festivals, including all activity necessarily incidental to attending music festivals that may lead to unintentional exposure or harm.
- 4. I, and/or my child(ren) understand and agree that this release includes any claims based on the actions, omissions or negligence of SMFA whether contraction of a Disease occurs before, during or after participation in any music festivals.
- 5. The execution of this Waiver and Release is a condition precedent to myself and/or child(ren) participating in the music festivals.
- 6. And, for and in consideration of being able to participate in the music festivals, I, and/or on behalf of my child(ren), irrevocably and unconditionally agree to fully indemnify the Released Parties from and against any loss, liability, damages, costs and expenses suffered by the Released Parties as a result of a claim made or proceedings commenced by myself or my child(ren) or by my heirs, representatives, assigns, against any other person, corporation or other entity (including the Crown) who claims, or whose representatives, successors claim contribution or indemnity from SMFA, or which otherwise results in SMFA suffering or incurring any loss, liability, damages, costs or expenses in relation to any Diseases.
